**THE REGULAR MEETING OF THE ELK MOUNTAIN TOWN COUNCIL WAS HELD MONDAY,

- CALL TO ORDER: Mayor Irene called the meeting to order at 6:32p.m. Pledge of Allegiance was recited.

- APPROVE MINUTES: Mayor Irene asked for approval of the January 14, 2013 Regular Meeting Minutes. **Cm. - CITIZENS ADDRESSING THE COUNCIL: Ken Casner spoke to the Council with concerns about the Town Bucket Truck bid process. He presented letters to the Council and Fire Chief Sherwood addressing his concerns. He ask that the letter be placed in public record.
- REPORTS: Reports were given by Fire Dept., SCWEMS, Water Dept., Public Works Dept., and HCJPB.
- Fire Dept.: Chief Sherwood said they have had no fire calls since last meeting. The County is taking applications for a technical maintenance person to work on vehicles in the county. This should help with the maintenance on the fire department equipment.
- SCWEMS: Representative Sikes told the Council they have had 5 calls YTD on the ambulance service.
- Water: Public Works Director Larsen told the Council that things are pretty much the same with the water system. There are still erratic fluctuations in the chlorination system. Larsen and Eastman went to Wamsutter to tour the water treatment plant there. Their chlorination system is an option to replace our existing one. Mayor Irene said that Larsen and Eastman will be meeting with Gary Steele, PMPC and a representative from our current chlorination system this week. He said the system "as is" is not acceptable. The Mayor has also requested the software for the SCADA system.
- Zoning: No Report
- Public Works: Public Works Director Larsen said things are going fine with Public Works. The lift station is operating at 6%. He has heard the State is looking at taking over the stream gauge on the Medicine Bow River. Owen Williams confirmed a conversation with the Rod Oliver that the State is planning on maintaining the gauging system.
- HCJPB: Representatives said the next Board meeting is schedules for this coming Thursday in Elk Mountain at 6:00pm.
