SCWEMS: Mayor Morgan Irene presented the SCWEMS report to the council. Morgan reported that the SCWEMS budget has been approved. The cost the municipalities are billed will not change for 2024-2025 fiscal year. SCWEMS is working with the Saratoga Medical Center transporting patients to other hospitals.

Cemetery Board: Brett Larson, the Chair for the cemetery board, presented the cemetery board report to the council. Brett reported that the cemetery section signs are up and look good. Brett will distribute the flags honoring the veterans for Memorial Day at the cemetery.

Museum Board: Angie Hobbs, the Director of the Museum, presented the museum board report to the council. Angie reported that the walls for the museum are almost done. The museum is hosting the annual Kenducky Derby fundraiser and the Elk Mountain birthday celebration BBQ on Monday May 27th, which is Memorial Day. **Cm.
