CITIZEN ADDRESSING THE COUNCIL: Yonne Johnson introduced herself to the Council. She has been in the CCEDC Directors position for about 3 months. She has been reaching out to the municipalities in the county to see if there are areas in economic development she can help with. Johnson has found funding for small projects from Sinclair and RMP.

Jon Nelson presented a task order for the design, bid, construction and post construction for the street improvement project. He said the town could go out to bid with a bid opening in December with work commencing next July thru September. If the Council wasn't comfortable, they have the right to reject any and all bids. A portion of the money for this project was coming from Gateway South Transmission Project and the remainder from reserves. **Cm. Jones made a motion to sign the contract with**Northfork Engineering for the Street Improvement Project; Cm. Kennedy seconded the motion; Cm. Hobbs Absent, Mayor Irene Aye, Cm. Jones Aye, Cm. REPORTS:

Fire Dept: The department purchased some new tools, and they will be retrofitting a 2003 International Truck for a quick attack, structural fire and wildland fire unit with impact funds. PW Director Page was asked to put together a bid on 2 generators and a side by side for the fire hall and department.

SCWEMS: Mayor Irene attended the SCWEMS meeting. The contract with Classic Air Ambulance Service and SCWEMS for service in their response area has been terminated. Classic cannot provide the "free" service to the area residence after October 1st. With remaining impact funds, they are looking at hiring off duty responders to cover the Medicine Bow area.

Public Works: Superintendent Page reported his sanitary survey is this coming week with EPA, he received the inspection write up from Inland Potables, the senior center remodel is coming along, he will be working on the fence at the sewer lagoon in the next few weeks, he worked with Jon Nelson on the

bids for the street project, he plans to work on potholes in the next few weeks, the town is now set up with an account at the Laramie Landfill, still working on getting the dumpsters together, asked Council for permission to purchase tools for the PW, request to purchase a bucket truck or manlift, town has issued several new building permits, he has been working with surveyors on the park land swap, WLC has promised a completion date of November 1st on the outstanding projects they are working on. The Council decided on a green and white street sign to replace the old ones. The lights on the bridge needed switched out and they are giving the town the poles for the ones that needed replaced. There was some discussion on where they could put them.
